As the neighbourhood is not located in a high-end area of the city; accessibility in terms of road maintenance is not prioritized during government projects. This limits the accessibility to schools and hospitals, and the poor drainage also contributes to the high levels of cholera during the rainy season.



## MR. MWALE

a small business owner in Chipata with limited access to office supply stores – Mr. Mwale recently opened his small business providing real estate services to the residents of Chipata. He is a family man, and because of his unique business service – he would want to be located in a central part of the town center to gain customers. This means most of his income goes to paying his office rentals and maintaining his family. Mr. Mwale would have to keep his office running and would need affordable office supplies to run his business functions without having his costs escalate.
