Following your recent submission of duly completed employer registration form, We are pleased to advise that your Institution has been registered with the National Pension Scheme as an Employer and has been allocated Account No. 262869 which you must quote in all transactions / correspondences with the Authority.

The effective date of your registration as an Employer is 26 APR 2017. By law, you are required to remit monthly contributions to the National Pension Scheme from the stated date. The said monthly contributions are due for payment on the 10th of each month and any late remittance of contribution will by Law attract an automatic penalty of 20%.

The monthly contributions facility is pegged at 10 percent of employees' monthly gross earnings subject to the gazetted monthly contributions ceiling in the year to which the earnings relate. However, employees whose monthly gross earnings are below K 16,000 or its equivalent in the old currency are exempted from contributing to the scheme.
